

# Impact Dogs Contract & Guarantee

This contract is between Impact Dogs (Obedient Warrior LLC) hereinafter referred to as "Impact Dogs" and the buyer hereinafter referred to as "BUYER" who is identified in "Buyer Information" section. This contract is also solely for the stated puppy or dog identified in "Puppy/Dog Information" section, hereinafter referred to as "dog".

**Vaccinations and Dewormer:** Impact Dogs assures that the dog has received at least one set of vaccinations which cover Distemper, Adenovirus Type 2, Parainfluenza and Parvovirus. Impact Dogs de-worms puppies at 2,4,6 & 8 weeks of age. The BUYER is fully responsible for continuing preventive care, vaccines, and treatment after the dog leaves Impact Dogs' premises.

**Hips and Elbows:** Impact Dogs guarantees the dog's hips & elbows against dysplasia as determined by the Orthopedic Foundation of Animals (OFA). If a BUYER so chooses to undergo the expensive process of certification of the dog's hips & elbows through OFA, the certification must be done after the dog reaches 24 months of age (required by OFA) and before the dog reaches 28 months of age. For female dogs bred prior to OFA certification (prior to 24-28 months of age) as outlined herein, the hip and elbow guarantee is voided. If the dog is diagnosed with hip or elbow dysplasia by OFA, official written documentation including films and any and all veterinary reports associated with the dysplasia diagnosis from the OFA must be sent to Impact Dogs. Impact Dogs will not honor written statements or exams from a personal licensed vet, only OFA. If the dog is diagnosed by OFA to have

dysplasia, Impact Dogs will compensate/refund the BUYER ½ the dog's purchase price (excluding any/all additional expenses; travel, shipping, food, vet supplies, veterinarian costs, etc.). Impact Dogs recommends feeding a large breed puppy food for the first 12 months of the dog's life to lessen the risk of dysplasia. If BUYER allows the dog to become highly overweight for the dog's size, the hip and elbow guarantee will be voided.

**Health:** Impact Dogs states that the dog is in good health at the time of pickup or shipping and promises to make the BUYER aware of any known health issues before the transfer of the dog to the BUYER. Impact Dogs will not guarantee against common dog issues which are regularly treated by basic veterinary care such as viral illness, parasites, bacterial infection, giardia, coccidiosis or kennel cough. Impact Dogs takes great measure to prevent such issues but cannot guarantee against them to their commonality within puppies and dogs and easability to treat.

Impact Dogs guarantees for two years from the date of purchase, against the dog's death due directly to a veterinarian's diagnoses of a congenital/genetic disease. Death caused by accidental events, contagious disease, infection, injury, ingestion of foreign object or substance or any other manner outside of congenital/genetic cause are outside of Impact Dogs' control and will not be guaranteed against. Written documentation of veterinary diagnosis of a dog's death by congenital/genetic cause must be provided to Impact Dogs within seven days of dog's death. Impact Dogs reserves the right to a second veterinary opinion to determine cause of death. If congenital/genetic cause of death is mutually found, Impact Dogs will refund the BUYER the purchase price of the dog (excluding any/all additional expenses; travel, shipping, food, vet supplies, veterinarian costs, etc.) or provide a replacement dog to the BUYER, of equal value when a dog of equal value is available.

The BUYER agrees to maintain the dog in good health, provide routine preventative health care, including but not limited to, inoculations/vaccines, internal and external parasites, and preventative medications. BUYER agrees to provide continuous fresh water and appropriate high quality food, in correct amounts appropriate to the dog's age, weight and lifestyle. If any of the stated care on behalf of BUYER has not been provided to the dog, the guarantees and warranties written herein will be voided.

All guarantees herein pertain to the original purchaser of the dog only.
